Towpath Tails Dog Park Terms & Conditions - 06 January 2024 vs06

Terms and conditions of use of Towpath Tails Dog Park Limited-

Important: By booking and/or using Towpath Tails Dog Park Limited you are automatically agreeing to the Terms and Conditions set out below.

We aim to be as accommodating and helpful as we can to ensure that you and your dogs have a great visit. But we do need to set out some terms for everyone's benefit.

1. Bookings

- Entry to and use of the Towpath Tails Dog Park facility is strictly by appointment only via the Wix booking system on Towpath Tails Dog Park Website. If you are not able to use the online booking facility, we will accept email and phone bookings.
- Bookings can be made for either the Paddock or the Coppice play areas.
- Bookings and booking enquiries can be made for: an 'Individual Booking' (including first time introductions and professional dog walkers), a 'Training Class Booking', or an 'Event Booking'.
- Any use of Towpath Tails Dog Park Limited without an approved booking will lead to the person(s) permitted
 use of Towpath Tails and its facilities being permanently revoked.

First time visitors - Introduction Visit

- All first time visitors MUST arrange an introduction visit. Here one of our team will show them how the site
 and access works and outline the major conditions of use.
- Introduction visits can be booked for either the Paddock or the Coppice area
- If you have booked online you will have confirmed at the booking stage that you have read and understood
 these Terms and Conditions. If you have booked via email or over the phone/text, then a copy of these
 Terms and Conditions will have been made available to you at your introduction visit or sent to you in
 advance.
- During your introduction visit it is your responsibility to ensure the facilities and the site are suitable and secure for your specific use (e.g fence height, fencing materials, and proximity to livestock and natural features).

Pricing

- Please refer to our booking pages on the Towpath Tails Dog Park website for details of the current pricing.
- Towpath Tails Dog Park reserve the right to alter the pricing structure for use of the Paddock or the Coppice without notice.

3. Payment

- When making your booking please give honest accurate details of the number of dogs you will be bringing by selecting the correct booking cost. Please let us know of any changes to these details before the booking takes place.
- Payment should be made online at the time of booking. If the booking is made via text, phone or email, payment can be made by bank transfer in advance or cash on the day on arrival.
- For individual bookings payment is via the online booking system where you can use major debit and credit
 cards via the Wix payment portal. For email, phone or text bookings please pay by bank transfer in advance,
 or by, by exception, we will accept cash on the day.
- For training classes and events we will agree the payment method with you at the time of confirming your bookings.

 Unless otherwise agreed payment of the full fee is required when booking and is non-refundable unless the hire is cancelled within the allotted date and time. (see Cancellations below) No online booking will be valid without payment.

4. Cancellations

• If you are unable to attend your booking for any reason please give us as much notice as possible and we will help you reschedule.

Individual bookings

- If you cannot reschedule, bookings are non transferable to other people and should be cancelled with at least 48 hours notice in order to receive a refund.
- Refunds will be issued in line with the Wix payment system processes. To cover the costs of online payments and the administration of refunds, a cancellation fee of £1 will be applied for each cancellation.

Event bookings and Dog training class bookings

- If you cannot reschedule, bookings are non transferable to other people and should be cancelled with at least 14 days notice in order to receive a refund.
- Rescheduling will be accommodated at no extra charge up to 14 days before the booked event/training class.
 Rescheduling requests of less than 14 days notice will incur an administration fee, which will be set out in your booking agreement.

5. Numbers of Cars People and Dogs

- There is a maximum number of 6 dogs per Individual booking subject to the agreed booking payment.
- For Training Class Bookings and Event Bookings the maximum number of dogs allowed in Towpath Tails will be subject to agreement between Towpath Tails Dog Park Limited and the customer and will be agreed prior to booking confirmation.
- There is a maximum of 6 vehicles allowed unless special arrangements have been agreed with Towpath Tails Dog Park Limited for a Training Class Booking or Event Booking.
- It is the responsibility of the customer making the relevant booking to ensure that all people visiting with them their 'guests' have read and understood these Terms and Conditions.
- There is no limit to the number of people who can visit on a booking provided that:
 - All government covid restrictions in force at the time of the booking are observed and followed
 - Customers and their guests abide by the law in force at the time in relation to those dogs listed on the Dangerous Dogs Act (DDA) 'Exempt Dogs' – please refer to section 10 below
 - The booking is only used for the purpose of dog exercise, play or training
 - All guests of the customer are known to the customer or where the customer is a dog trainer, are clients of the dog trainer.
- Children under the care and/or control of the customer or a guest are welcome but MUST be supervised at all times whilst on the site and must not be left alone in the Paddock or the Coppice, or anywhere on the site. If you are alone with your child/children, and need to return to your car, please ensure your dog(s) and children return with you.
- Children should not be allowed to climb on any equipment, fence, gate or seating.

Please remember this is a dog exercise park and not a children's playground.

Responsibility for any child remains entirely with the customer.

6. Car Parking

- Customers of Towpath Tails Dog Park Limited must only park their cars in the designated car park area or the allocated Paddock or Coppice parking space. The main car park is shown on the map on the Towpath Tails Dog Park website and parking information will be provided on your induction visit.
- Parking is at your own risk and Towpath Tails Dog Park Limited accepts no liability for any loss or damages sustained in the use of the car park or parking spaces.

7. Opening Times

- For safety reasons the fields will be open at specific times during the summer and winter seasons. (Please see Opening Times on the Towpath Tails Dog Park website for current opening times). No access to the field is allowed outside of these opening times, unless by express agreement with Towpath Tails Dog Park Limited.
- Please be aware that there is no lighting in either the Paddock or the Coppice and so the facilities will always
 close around or before dusk to ensure that customers and their dog(s) can return safely to the car park and
 exit.

Withdrawal of Facility

- Towpath Tails Dog Park Limited reserve the right to withdraw permission to use the facility at their discretion, for example on the basis of weather conditions, certain days when maintenance is required, or where customers have not complied with the conditions of use.
- Subject to the reason for the withdrawal of the facility, any advanced payment may be refunded. However,
 Towpath Tails Dog Park Limited shall be under no liability for any other expenses incurred or loss sustained
 by a customer as result of the use of the facility being withdrawn at our sole discretion.

8. Entering & Exiting the dog park

- The parking area for both the Paddock and the Coppice is within a gated access (Main Entrance Gate) and is accessed by vehicle or on foot. (please see map for details).
- The main entrance gate will generally remain shut and locked via a coded access during opening hours.

 Customers will be provided with a means of unlocking the main entrance gate ahead of their appointment.
- Customers MUST NOT under any circumstances give any gate code to anyone else, including their guests, or leave the gate unlocked for another user.
- The codes are subject to change at any time by Towpath Tails Dog Park Limited without notice.
- Once having gained access to the gated car park you must close and resecure the main entrance gate behind you.
- Whilst in the car park area and walking to and from the access gates to the Paddock and the Coppice all dogs
 must be kept on a lead. For those customers bringing 'Exempt Dogs' please refer to the special clauses in
 section 10.
- Beyond the main car park both play areas are double gated for security and safety.
- Towpath Tails Dog Park Limited accepts no liability for any damage or loss sustained whilst customers are in the car park or either parking bay.
- If you arrive early, please remain in your car with your dog(s) until the previous customers, who are using the
 play area you have booked, have competed their visit and secured their dog(s) back into their car. If there is
 no other car in the car park or respective parking space, please feel free to call David to check if you can start
 your booking early.
- For customers with guests (including dog trainers) the customer is responsible for ensuring that all guests have arrived and for escorting them safely from the car park to the Paddock or Coppice as appropriate. And at the end of the booking session for ensuring that the Paddock or Coppice, as appropriate, is vacated, with the gate closed and that all dogs and guests return and exit safely.

- If you arrive late for your booking this does not alter the end time of your booking. You should ensure that you vacate the respective play area on time (no later than 5 minutes before the end of your booked session) so as not to cause any delay to anybody waiting to start their booking. if you do arrive late, please feel free to contact David on 07891761705 and he will let you know if there is another customer after you. If he can extend your appointment he will.
- The customer agrees not to enter the Paddock or Coppice with or without their dog(s) whilst the respective play area is occupied by any other persons, unless permission is given by that person. If the play area you have booked is occupied during your timeslot or if the previous customer stays past your start time and does not appear to be leaving, please check your booking time or call David on 07891761705 or call at Lock House for assistance. You MUST NOT open the Paddock or Coppice gates and enter the play areas as there may be a reactive or dangerous dog present.
- Customers are expected to use the play area that they have booked and not to encroach into the other play area.

Access to the Paddock

- Access to the Paddock is via a gated driveway and 2 further gates for safety and security.
- After entering the main entrance gate Paddock users must access the Paddock driveway via the 1st Paddock
 Gate, close the gate behind them and then drive slowly along the Paddock access driveway and park one car
 within the dedicated Paddock parking area which is beyond the 2nd Paddock gate.
- Where the customer is bringing an 'Exempt Dog' there is a padlock for the 1st Paddock gate which must be used to lock the 1st Paddock Gate while in use please refer to section 10. This access ensures that Paddock customers and their dogs are not in direct contact with Coppice customers and their dogs.
- The driveway from the car park to the secure paddock and back at the end of your appointment is very short no more than 1 minute drive; it is alongside, but secure from the Coppice. Whilst this area is secure it cannot be guaranteed that it is secure for dogs off lead either dogs that dig or dogs that can jump fences. Under no circumstances are dogs allowed to run free within the car park or the driveway. You must ensure that all dogs are kept on their leads until you have reached and are inside the secure Paddock with the 3rd Paddock gate closed.
- Once you have parked and closed the 2nd Paddock gate you are then able to access the Paddock through a 3rd Paddock gate. Once inside the Paddock you must ensure that the 3rd Paddock gate is closed securely behind you. The Paddock is then secure and you may release your dog(s) from their leads.
- Similarly, at the end of your appointment you must ensure all dogs are on lead before opening the 3rd
 Paddock gate. Once they are secure in your car you can open the 2nd Paddock gate and drive back to the car park for your exit.
- If you have come on foot / or choose to leave your car in the main car park, you can if you wish walk the length of the driveway to access the Paddock. If walking you MUST ensure that your dog(s) remain on their lead until you are within the actual Paddock space and have safely secured the 3rd Paddock gate. The same is required for the return at the end of your visit secure your dog(s) on their lead before opening the 3rd Paddock gate and leaving the Paddock space. Special arrangements are required in respect of locking the 1st Paddock gate if you as the customer are walking an 'Exempt Dog' along the Paddock driveway.
- You are not permitted to walk your dogs on any other route than the direct Paddock driveway. Failure to
 observe this condition will result in your withdrawal of use of Towpath Tails Dog Park Limited.
- Customers must ensure they:-
 - close the 3rd Paddock gate securely when leaving the Paddock;
 - close the 1st Paddock gate to the car park securely on leaving the Paddock access area;
 - and that they close the main entrance gate when exiting the car park.
- Customers must leave the Paddock 5mins before the end of the booked period to allow time to drive/walk back to their car, secure their dogs in their car and vacate the Paddock parking space and driveway, ensuring that they are back within the car park no later than the end of their scheduled booking. Therefore, if you will need time to get your dogs back into the car please kindly leave the Paddock a little earlier.

- Customers have use of the shelter and benches in the Paddock. You will also find a notice with our contact details and the contact emergency details for a local vet. Please keep the shelter area tidy.
- For those customers bringing 'Exempt Dogs' to the Paddock please refer also to section 10.

Access to the Coppice

- There is a single discreet parking space for the Coppice which is accessible from the car park and is secured by a gate (1st Coppice gate). Where the customer is bringing an 'Exempt Dog' there is a padlock for the 1st Coppice gate which must be used to lock the 1st Coppice Gate while in use please refer to section 10. This access ensures that Coppice customers and their dogs are not in direct contact with Paddock customers and their dogs.
- After entering the main entrance gate Coppice users may park one car within the Coppice access area which is accessible alongside the main cabin.
- Immediately behind the cabin is the 2nd Coppice gate, which allows access into the secure Coppice area. The area between the 1st and 2nd Coppice gates is secure and dogs can be let off lead directly from the car.
- Customers should enter the Coppice via the 2nd Coppice gate. Once inside the Coppice you must ensure that the 2nd Coppice gate is closed securely behind you. The Coppice is then doubly secure for you and your dog(s).
- Similarly, at the end of your appointment you must ensure that the 2nd Coppice gate is closed when you have finished your session, and that your dogs are back in the car before leaving through the 1st Coppice gate.
- Customers must ensure they :-
 - close the 2nd Coppice gate securely when leaving the Coppice;
 - close the 1st Coppice gate to the car park securely on leaving the Coppice access area;
 - and that they close the main entrance gate when exiting the car park.
- Customers must vacate the Coppice parking space no later than the end of their scheduled booking to allow
 the next customer to park securely in the Coppice access area. Therefore, please ensure that you leave the
 Coppice allowing enough time to get your dogs back into the car and drive back into the main care park.
- Customers have use of the shelter in the Coppice which has a bench/seat. You will also find a notice with our contact details and the contact emergency details for a local vet. Please keep the shelter area tidy.
- For those customers bringing 'Exempt Dogs' to the Coppice please refer also to section 10.

9. Code of Ethics

- Customers must ensure that all dogs using Towpath Tails Dog Park Limited are up to date with their dog(s)
 respective vaccinations, flea, worming, and tick control and that where they are attending with other dogs
 (ie; within a group session, event or training), that they have their own appropriate public liability insurance.
- All dogs must wear their collars with an up to date tag and be micro-chipped.
- For those customers bringing 'Exempt Dogs' to Towpath Tails Dog Park Limited customers must ensure that they and their dogs comply with all the required laws in force at the time of the booking please refer also to section 10.
- Any customer or guest observed mistreating any dog on the site will be asked to leave the site immediately
 forfeiting any and all payments made and will be reported to the relevant authorities.
- If your dog(s) or any dog(s) they live with are showing any signs of ill health (coughing, diarrhoea, vomiting, general illness, lethargy etc.) you should cancel any pending booking. This is to preserve the health of all dogs visiting the site as some may have weakened immune systems.
- All dog(s) must be on a lead when not in a secure play area. Specifically, they must be on a lead when walking between the car parking area / Paddock parking space and the Paddock on entry and exit.
- All professional dog trainers must provide a copy of their Professional Indemnity and Public Liability
 Insurance prior to being granted permission to use Towpath Tails facilities to run training courses. Inability to

- provide a copy will mean that permission to use the park will be withheld. Insurances must be kept up to date and valid for the intended duration of use of the dog park.
- The training of a dog or dogs for fighting is strictly prohibited. Any customer or guest found to be training a dog in such a way on the site will asked to leave the site immediately forfeiting any and all payments made and will be reported to the relevant authorities.
- The Paddock borders a private residence, the canal tow path and the Coppice, and the Coppice borders a private residence and the Paddock. Please be respectful of the noise level and language used when using the either area of the park.

10. Banned/Exempt Dog Breeds - Including XL Bully 'Types'

- This clause is for those customers who wish to bring an 'Exempt' Dog / dog that is subject to the Dangerous Dogs Act. Eg, a dog that is XL Bully or has been 'typed' as XL bully.
- We want to ensure that customers who have dogs listed on the DDA can enjoy the facilities at Towpath Tails Dog Park Limited. This clause has been stipulated by our insurance providers and therefore relates to any customer who wishes to bring an 'Exempt Dog' breed including XL Bully type dogs to Towpath Tails Dog Park Limited from 31.12.23. Please do check theses Ts&Cs regularly as we are continually pushing, as are other field owners, to try and get insurers to improve their conditions for dog owners.
- Towpath Tails Dog Park Limited meets the criteria for allowing 'Exempt Dogs' as follows:
 - o The field is private property with no public access passing through.
 - o Each field is securely fenced and can be locked so the dog cannot escape.
- The good news is, once securely in the Paddock or the Coppice which means customers who bring an Exempt/banned dog breed, MUST ensure that the main car park entrance gate is closed and locked and that the relevant Coppice or Paddock gates, once the customer and the dog are inside, are also securely closed and locked your dog will be able to enjoy a lead & muzzle free session at Towpath Tails Dog Park Limited. There are however some restrictions with regards to field use and occupancy by you as the customer which are set out below and MUST be adhered to:
 - I. The customer's exempted dog(s) must be registered (by 31.1.24 for XL bully 'types') with the index of exempted dogs (IED) and a copy of the life certificate is to be provided to Towpath Tails Dog Park Limited prior to your visit. Please ensure you send this to us in reply to your booking confirmation.
 - II. The customer must have public liability insurance for the dog(s) and a copy of the public liability insurance certificate for the dog is to be provided to Towpath Tails Dog Park Limited prior to your visit. Please ensure you send this to us in reply to your booking confirmation.
 - III. The dog is neutered in line with the government timescales/age.
 - IV. The dog is micro chipped.
 - V. The field is securely fenced and locked so the dog cannot escape. (please refer to the access instructions above)
 - VI. The dog is kept on a lead and muzzled until they are securely within the Coppice or Paddock as per the booking, and that the Coppice or Paddock gate (as relevant to the booking) is shut and locked after entering the field, and remains locked for the duration of the booking.
 - VII. The dog's lead and muzzle can be removed once inside the secured Paddock or Coppice field as per the booking.
 - VIII. The dog is put back on a lead and muzzled before opening the gate to leave the Coppice or the Paddock field and that the dog is secured in the car before exiting the parking space to the main car park.
 - IX. If the customer household has more than 1 dog, all the household dogs can come to the field and be off-lead and unmuzzled including the banned/exempt breed types with their own household dogs. Only 1 handler (over the age of 18) from the household is required to be with the dogs.

X. Customers from multiple households can now attend a joint booking session even if there are banned/exempt dogs present. However, at present, If there are dogs from different households, the exempted/banned dog breeds will need to remain muzzled and on a lead at all times with a 1:1 handler; as at this time no people from other households can be present in the field where an exempted/banned dog is unmuzzled and off-lead.

As/when DEFRA or our Insurance company provide further clarity/updates these Terms and Conditions will be updated accordingly.

11. Maintenance & Health & Safety

- The boundary and security of the Paddock and the Coppice are regularly checked. However, the customer is
 advised to check that they are satisfied with the height, safety and condition of the fencing prior to using the
 respective play area and to notify Towpath Tails Dog Park Limited on 07891761705 of any discrepancies or
 concerns.
- We will provide water either direct from a tap or via a container and a bowl for water for the dog(s) in each play area. Customers should use this to provide adequate drinking water for their dog(s) especially in the hotter weather. The water is for drinking water for your dog or for washing mud off dogs before returning to your car. Please do not use the water for play.
- There is at least one dedicated dog (poo) waste bin located on site within each play area and Customers must only use this for the disposal of dog waste.
- We want to keep our park areas clean and tidy for everyone's safe use. Customers MUST pick up any faeces from your dog(s) and secure them in dog poo bags before either taking them away with them or placing them in the designated dog (poo) waste bins provided. There are polite reminders on the entrance gates to each play area. Anyone found to disregard this condition may have their permission to use Towpath Tails withdrawn.
- There is no general waste bin on site. Please do not leave litter within the Paddock, Coppice or on site.
 Please take all general litter and waste away with you.
- Towpath Tails is a countryside based facility and as such although maintained by ourselves there may be
 natural hazards. For example:- sticks, branches, stones, tree roots and stumps, small holes, thistles and
 stinging nettles in the Paddock, the Coppice and along the driveway between the car park and the Paddock.
- There are no toilets on site.
- Both play areas include a small shelter with seating for people to be under cover from rain and the sun on hot days.
- In the summer months, where possible, we will make a small paddling pool available in both the Coppice and the Paddock, for the dogs to play in / cool off in. We aim to keep this topped up regularly. If you arrive for your visit and the pool is low on water please call David on 07891761705 and he will arrange to have it topped up.
- The Paddock has access to an area of the River Avon tributary. This is natural flowing water. However, this
 cannot be guaranteed if hot weather causes the riverbed to become dry. If using the Paddock in freezing
 conditions, please also be mindful that the river may freeze. (it has been known!)
- Customers may bring a drink for themselves but are not permitted to picnic anywhere on the site. The use of portable and/or disposable BBQs is not permitted under any circumstances.
- The agility equipment within the Paddock is provided for the use of your dog(s). We ask that neither
 customers, guests nor children climb on, or use any equipment or structures within the Paddock that are for
 the use of dogs only. Towpath Tails Dog Park Limited will not accept any liability for personal injury however
 caused.
- The trees within the Coppice are living, various sizes and growing. As such all trees must be treated with respect and MUST NOT be climbed on or wilfully damaged. Anyone found damaging trees will have their access to the park withdrawn permanently and will be fined if the damage is such that the tree is no longer viable.

- Customers and their children must not climb on trees, gates fencing, posts or any structure on site.
- Use of any equipment or structures within the Paddock or Coppice (provided by Towpath Tails Dog Park Limited or not) is entirely at your own risk and Towpath Tails Dog Park Limited will not accept any liability for any injury to people or dogs however caused.
- We inspect the Paddock, Coppice and fencing weekly to ensure it is healthy and secure but please notify us if you have any concerns.
- Please discourage your dog(s) from digging; but if they do please fill in any resultant holes from your dog(s) digging prior to leaving the respective play area so that it remains safe for the next customer.
- Towpath Tails Dog Park areas may get wet and muddy from time to time (especially in the winter months).
 Also, the ground level is likely to be uneven and so we advise that customers ensure adequate and suitable footwear is worn at all times.
- You may of course bring toys and training aids for your dog to use while in Towpath Tails Dog Park. Please
 ensure that you remove all of your personal dog toys and training aids on leaving the Paddock or Coppice,
 being particularly vigilant to remove any broken toys or balls. Tennis balls in particular pose a choking risk to
 any dog.
- Please ensure that the equipment and any toys provided by Towpath Tails Dog Park Limited are left in the Paddock or Coppice, as appropriate, when you leave.
- In the interest of safety Towpath Tails Dog Park Limited operates a strict no smoking, vaping or use of pipes
 policy anywhere on the site. Anyone found violating this policy will have their permission to use the dog park
 withdrawn.
- Do not bring any article of an inflammable or explosive character, or that provides an offensive smell, or CFC or any civil, electrical, gas or any other apparatus onto the Towpath Tails Dog Park site. The use of portable and/or disposable BBQs is not permitted.
- Do not operate the release of any high flying object on the Towpath Tails Dog Park site without the prior written consent of Towpath Tails Dog Park Limited, the Civil Aviation Authority and the relevant airports.
- At no time should any dog(s) be tethered to any structures anywhere on the site, e.g. Fencing, Posts, Gates,
 Trees.
- Dogs MUST NOT be left unattended at any time. You should accompany your dog(s) at all times such that you
 are aware of what they are doing, and can ensure they are safe and that you are complying with these Terms
 and Conditions.
- In accordance with the law regarding 'Responsible Dog Ownership' customers are entirely responsible for their and their dog(s) safety whilst at Towpath Tails Dog Park Limited. The law states that you should be in control of your dog(s) at all times. This law still applies at Towpath Tails Dog Park regardless of if you are alone, or a Towpath Tails Dog Park representative is present.
- If any person using the Paddock or the Coppice, or their dog(s), cause any damage the customer will be required to pay for any repair.
- The Paddock and the Coppice are individually surrounded by a 6 foot high fence with deer wire and small rabbit fencing to the lower ground level. However, if your dog(s) can jump high fences or is/are likely to dig themselves out, then the play areas may not be totally secure for them.

We cannot accept responsibility for escapees

12. Right of Entry

- Towpath Tails Dog Park Limited representatives will be allowed access onto the site at any time to carry out inspections and any decisions made by Towpath Tails Dog Park Limited regarding safety and fitness of use, will be binding.
- Towpath Tails Dog Park Limited reserve the right to refuse permission to or evict any persons from the site.

13. Emergencies

- Towpath Tails Dog Park Limited has the right to cancel any booking forthwith in the event that Towpath Tails
 Dog Park Limited is affected by an emergency / 'Act of God' / government instruction at any time. Towpath
 Tails Dog Park Limited will refund any fees paid in these circumstances.
- If you encounter a problem while using the dog park, please call David on 07891761705 or call at Lock House.
- In case of a medical emergency with your pet details of a local emergency vet service are provided on a notice within the shelters in the Paddock and the Coppice.

14. Variations to the Agreement

Towpath Tails Dog Park Limited reserves the right to vary these terms and conditions at any time. Any
variations so made should be deemed to be incorporated in these conditions.

15. Marketing & Publication

 Towpath Tails Dog Park Limited reserves the right to use any material including texts and images published by or provided by customers to Towpath Tails Dog Park (in any format) for our website, social media pages and communications, for the purposes of marketing and promotion.

16. Preservations of Rights
